

ORDINANCE NO. 2024 -4

**AN ORDINANCE AMENDING ORDINANCE NO. 2024-3  
MAKE TECHNICAL CORRECTIONS AND  
TO ADD PROVISIONS FOR COMMERCIAL DUMPSTERS  
AND DECLARING AN EMERGENCY**

---

WHEREAS, on May 20, 2024, the City Council adopted Ordinance No. 2024 - 3 establishing rates for solid waste services and

WHEREAS there is a need to amend said ordinance to make technical corrections and to make provisions for commercial dumpster services;

BE IT, THEREFORE, ORDAINED that:

Section 1. Section 10 of Ordinance No. 2024-3 is amended to strike the word “sewer” and substitute the word “water” and include a monthly rate for additional residential receptacles as follows:

“Section 10. The monthly rates set out on the attached table are hereby fixed for the services and goods provided by the Hamburg Garbage Service to commercial users, to be collected with each customer’s ~~sewer~~ water bills each month. Residential customers are not permitted to specify pick up more than one time per week. The Residential Basic Rate shall be \$20.00 per month plus \$4.35 per month for each residential receptacle in excess of one.”

Section 2. The Hamburg Garbage Service is authorized to offer commercial dumpster services at the following rates and on the following conditions:


- a. Rates.
  - i. Service for two cubic yard containers shall be \$75.00 per month;
  - ii. Service for four cubic yard containers shall be \$100.00 per month;
  - iii. Service for six cubic yard containers shall be \$135.00 per month.
  - iv. All rates are based on pick up no more than once per week.

- b. Placement: Containers Must be placed within an area without obstructions with the following conditions:
  - i. 6 feet of clearance from the back and both sides;
  - ii. Front must be completely clear of obstructions for ease of pickup;
  - iii. Cannot obstruct traffic flow, visibility, or pedestrian pathways;
  - iv. Position of the dumpster must be away from corners, fire hydrants, and any other road infrastructure;
  - v. Cannot be placed on public streets and right of ways;
  - vi. Cannot be placed in areas of emergency access;
  - vii. Must be placed on firm and level ground. Soft or unstable ground will result in a missed pickup if the truck cannot access the container; and
  - viii. No overhead obstructions.
  
- c. Locking of containers is permitted under the following conditions:
  - i. If a lock is installed on the dumpster then one spare key must be supplied to the city for access as needed; and
  - ii. Long shackle or cable locks are required if a lock is used.
  
- d. Multiple dumpsters. Multiple dumpsters shall be placed at least 6 feet apart.

Section 3. Any and all provisions of other ordinances not inconsistent with this ordinance shall remain in full force and effect.

Section 4. The orderly pick up and disposal of Solid Wastes being essential to the health and welfare of the citizens of Hamburg, an Emergency is declared to exist and this Ordinance shall be in full force and effect from and after its passage.
