## **BUILDING PERMIT FEES**

- a) \$20.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$500.00 THROUGH \$2,000.00;
- \$50.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$2,001.00 THROUGH \$20,000.00;
- c) \$75.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$20,001.00 THROUGH \$50,000.00;
- d) \$100.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$50,001.00 THROUGH \$100,000.00;
- e) \$250.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$100,001.00 THROUGH \$500,000.00;
- f) \$500.00 FOR CONSTRUCTION WITH A PROJECTED COST OF \$500,001.00 THROUGH \$1,000,000.00;
- g) \$1,000.00 FOR CONSTRUCTION WITH A PROJECTED COST IN EXCESS OF \$1,000,001.00
